

- Repeated coughing
- Shortness of breath or difficulty breathing
- Wheezing
- Chest tightness or pain
- Palpitations
- Nausea or unusual fatigue
- Lightheadedness


HUMBOLDT COUNTY: Orleans, Hoopa, Weitchpec

Smoke levels in these areas have been classified as *Unhealthy* and are creating a health hazard. Depending upon your proximity to the fires, smoke concentrations could range from Unhealthy to Hazardous throughout the day. These conditions are problematic for those with health conditions. Smoke Levels continue to be monitored. Please watch for updates.

Wildfire Smoke Public Service Announcement

Smoke, haze, and degraded air quality conditions continue throughout Humboldt, Del Norte and Trinity Counties due to the numerous fires in the Six Rivers and Shasta-Trinity National Forest as well as State Responsibility Areas. A strong high pressure is preventing smoke from dispersing over much of northern California.

Today will be similar to yesterday, as smoke dispersion will be limited due to weak transport wind over the area. Despite observable haze, current monitor results show particulate matter concentrations in the Moderate range in the greater Humboldt Bay and Eureka area. Smoke will remain entrenched in the Humboldt and Trinity River valleys. These conditions are expected to last through Wednesday evening, with some relief Thursday and Friday. It is anticipated that areas such as Weitchpec, Hoopa and areas in the Klamath River drainage may again experience a few hours of very high smoke concentrations.

Air monitors in Hyampom, Hayfork, Willow Creek and Burnt Ranch are reporting Hazardous conditions. Both an Unhealthy Advisory and Hazardous Alert have been issued for several communities near the fires (see www.ncuaqmd.org).

These are the main fires of interest that are generating smoke:

Mad River Complex (Humboldt/Trinity County)
Humboldt Complex (Humboldt County)
Route Complex (Humboldt County)
Nickowitz Fire (Humboldt/Del Norte County)
Gasquet Complex (Del Norte County)
South Complex (Hyampom (Trinity County)
River Complex (Humboldt/Trinity County)
Fork Complex (Trinity County)
Rocky Fire – Lower Lake (Lake County)

Health Information for Smoke Impacts

Concentrations of smoke may vary depending upon location, weather, and distance from the fire. Smoke from wildfires and structure fires contain harmful chemicals that can affect your health. Smoke can cause eye and throat irritation, coughing, and difficulty breathing. People who are at greatest risk of experiencing symptoms due to smoke include: those with respiratory disease (such as asthma), those with heart disease, young children, and older adults.

These sensitive populations should stay indoors and avoid prolonged activity. All others should limit prolonged or heavy activity and time spent outdoors. Even healthy adults can be affected by smoke. Seek medical help if you have symptoms that worsen or become severe.

If you can see, taste, or feel smoke, contact your local health department and/or primary healthcare provider. This is especially important if you have health concerns, are elderly, are pregnant, or have a child in your care.

Follow these general precautions to protect your health during a smoke event:

- Minimize or stop outdoor activities, especially exercise
- Stay indoors with windows and doors closed as much as possible
- Do not run fans that bring smoky outdoor air inside examples include swamp coolers, whole-house fans, and fresh air ventilation systems
- Run your air-conditioner only if it does not bring smoke in from the outdoors. Change the standard air conditioner filter to a medium or high efficiency filter. If available, use the "re-circulate" or "recycle" setting on the unit
- County Do not smoke, fry food, or do other things that will create indoor air pollution

If you have lung disease (including asthma) or heart disease, closely monitor your health and contact your doctor if you have symptoms that worsen.

Consider leaving the area until smoke conditions improve if you have repeated coughing, shortness of breath, difficulty breathing, wheezing, chest tightness or pain, palpitations, nausea, unusual fatigue, lightheadedness.
